

Dear Sir or Madam;

Thank you for inquiring about the removal of suspected infringing items and materials from our site. If you are not an intellectual property (e.g., copyright, trademark) owner you may report infringing items to our Community Watch program (<http://pages.ebay.com/help/basics/select-RS.html>). If you are an IP owner we encourage you to join our Verified Rights Owner (VeRO) Program™, which was created to help intellectual property owners protect their rights by facilitating and simplifying the searching, reporting and removal of infringing items on our site. To join our VeRO Program we require that you fill out the attached form and addendum.

The information requested by this form is intended substantially to track the requirements of the Digital Millennium Copyright Act, 17 U.S.C. Section 512 (c)(3)(A), which provides:

To be effective under this subsection, a notification of claimed infringement must be a written communication provided to the designated agent of a service provider that includes substantially the following:

- (i) A physical or electronic signature of a person authorized to act on behalf of the owner of an exclusive right that is allegedly infringed.
- (ii) Identification of the copyrighted work claimed to have been infringed, or, if multiple copyrighted works at a single online site are covered by a single notification, a representative list of such works at that site.
- (iii) Identification of the material that is claimed to be infringing or to be the subject of infringing activity and that is to be removed or access to which is to be disabled, and information reasonably sufficient to permit the service provider to locate the material.
- (iv) Information reasonably sufficient to permit the service provider to contact the complaining party such as an address, telephone number, and if available, an electronic mail address at which the complaining party may be contacted.
- (v) A statement that the complaining party has a good faith belief that use of the material in the manner complained of is not authorized by the copyright owner, its agent, or the law.
- (vi) A statement that the information in the notification is accurate, and under penalty of perjury, that the complaining party is authorized to act on behalf of the owner of an exclusive right that is allegedly infringed.

Notification from a copyright owner or from a person authorized to act on behalf of the copyright owner that fails to comply substantially with the provisions above shall not be considered as providing actual knowledge or an awareness of facts or circumstances from which infringing activity is apparent. Please make requests to end auctions at least 48 hours before the auction is scheduled to expire to ensure us ample opportunity to review and end the auction.

Please provide a Notice of Infringement form each time you wish to report alleged acts of infringement and return it to the address provided. eBay requires that you sign and fax the first Notification of Infringement form to us at (408) 516-8811. *So long as subsequent Notice of Infringement forms are reported by an authorized person from the same company or firm, future notices may be sent via email to a special address that will be provided for your convenience.* However, the email notification must contain substantially the same information as is contained in our form. If the identified auctions are ended at your request, eBay will notify the seller and bidders by email of that fact and provide them with the IP Owner's name and email address (which you provide) as well as eBay's email address in the event of a dispute.
